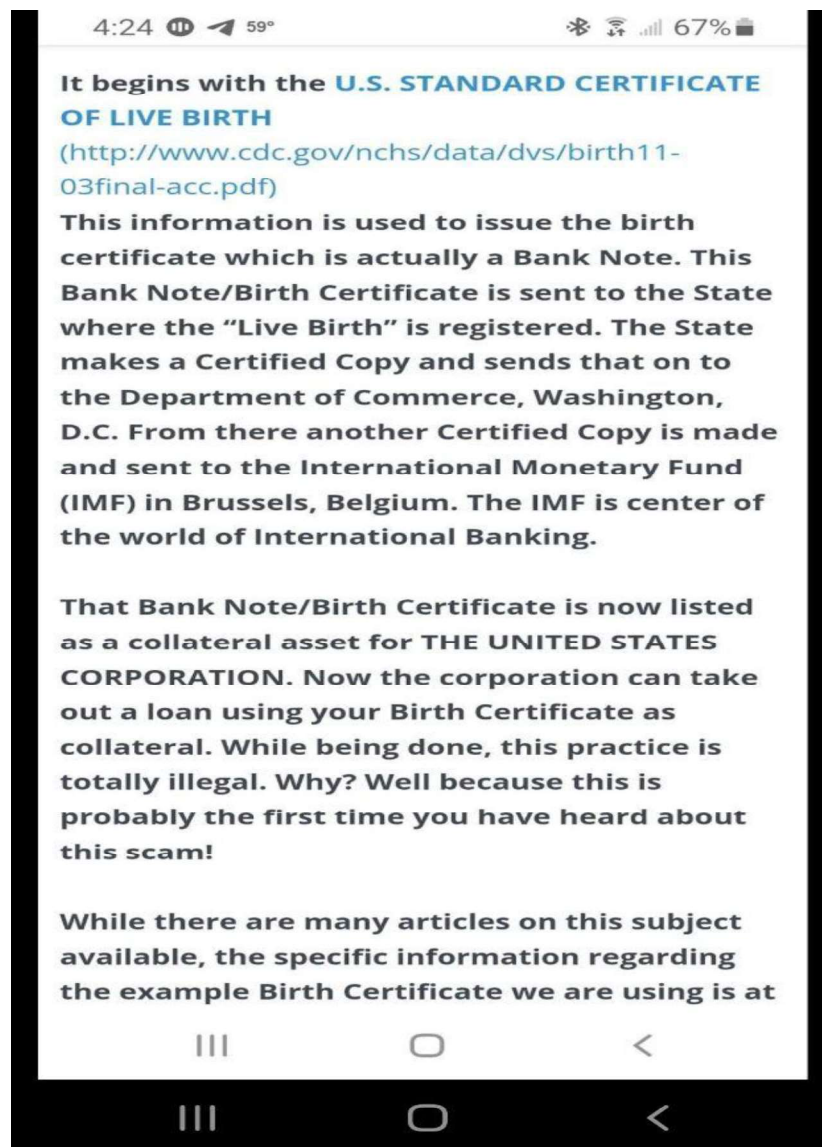

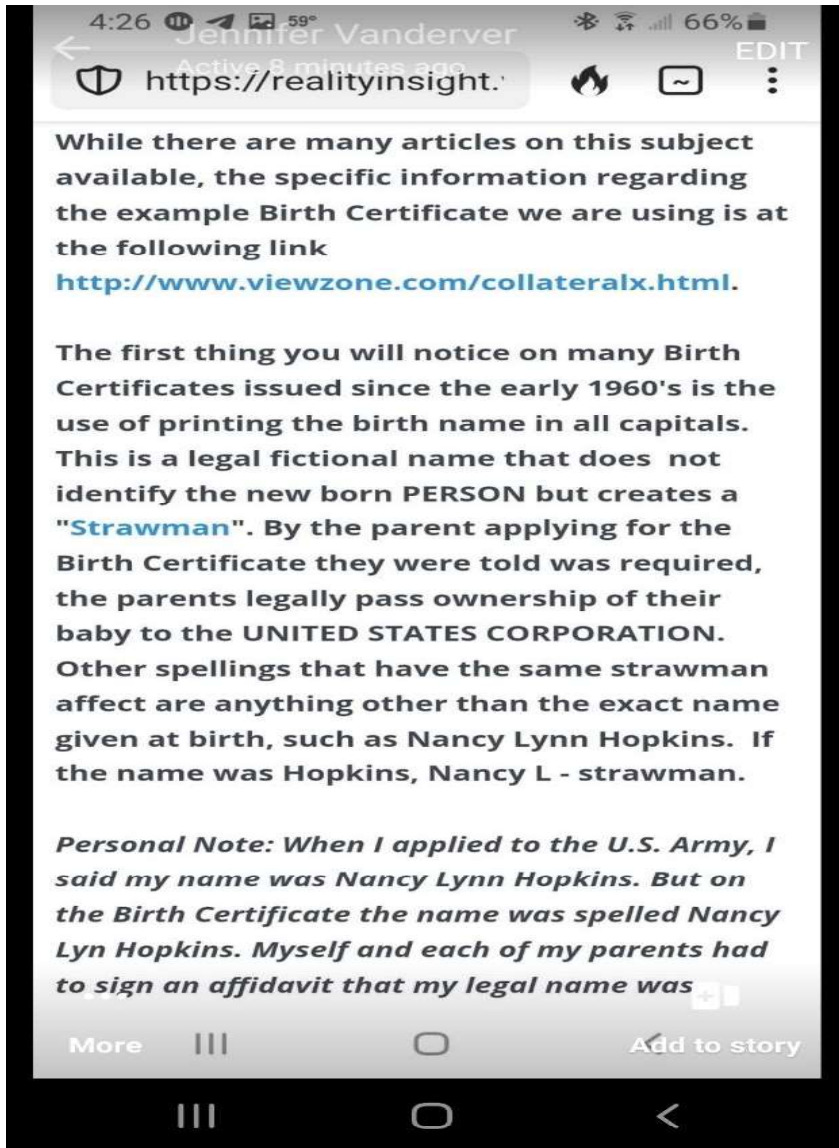

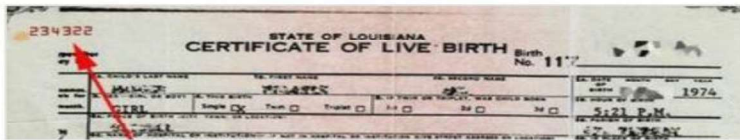




"Strawman". By the parent applying for the Birth Certificate they were told was required, the parents legally pass ownership of their baby to the UNITED STATES CORPORATION. Other spellings that have the same strawman affect are anything other than the exact name given at birth, such as Nancy Lynn Hopkins. If the name was Hopkins, Nancy L - strawman.

Personal Note: When I applied to the U.S. Army, I said my name was Nancy Lynn Hopkins. But on the Birth Certificate the name was spelled Nancy Lyn Hopkins. Myself and each of my parents had to sign an affidavit that my legal name was spelled Lynn and not Lyn. Just now understanding why this was required.

Also note The Words "American Bank Note Company". This is a blown up copy of the words on the edge (see red arrow). You will only get a copy of the certificate or as in the example, a certified copy of the original.

PERSONAL TREASURY ACCOUNT (how to find)

To figure out the value of your personal treasury account go to:

<https://www.treasurydirect.gov/BC/SBCPrice>

1. Set the type to E Bonds (Before 1980) or EE Bonds (After 1980) Your birthdate!!!
2. Set Denomination to 10,000 (The highest it can currently calculate)
3. Put in your SSN with Dashes
4. Issue Date = your birth month and year.

Hit Calculate.

10000 is the highest it can currently calculate for denomination, so you have to times your value by 100 to get the actual number. So for example, if your value is 50,000 then your actual value would be 5,000,000.

Under that box is another link "Calculate another bond"

If your bond matures after 1980, change it to Series EE Bond and the Issue date the year the previous one matured.

Now from what I heard if you take this total and divide it by 20% this is the amount of credit that is being traded in your name.

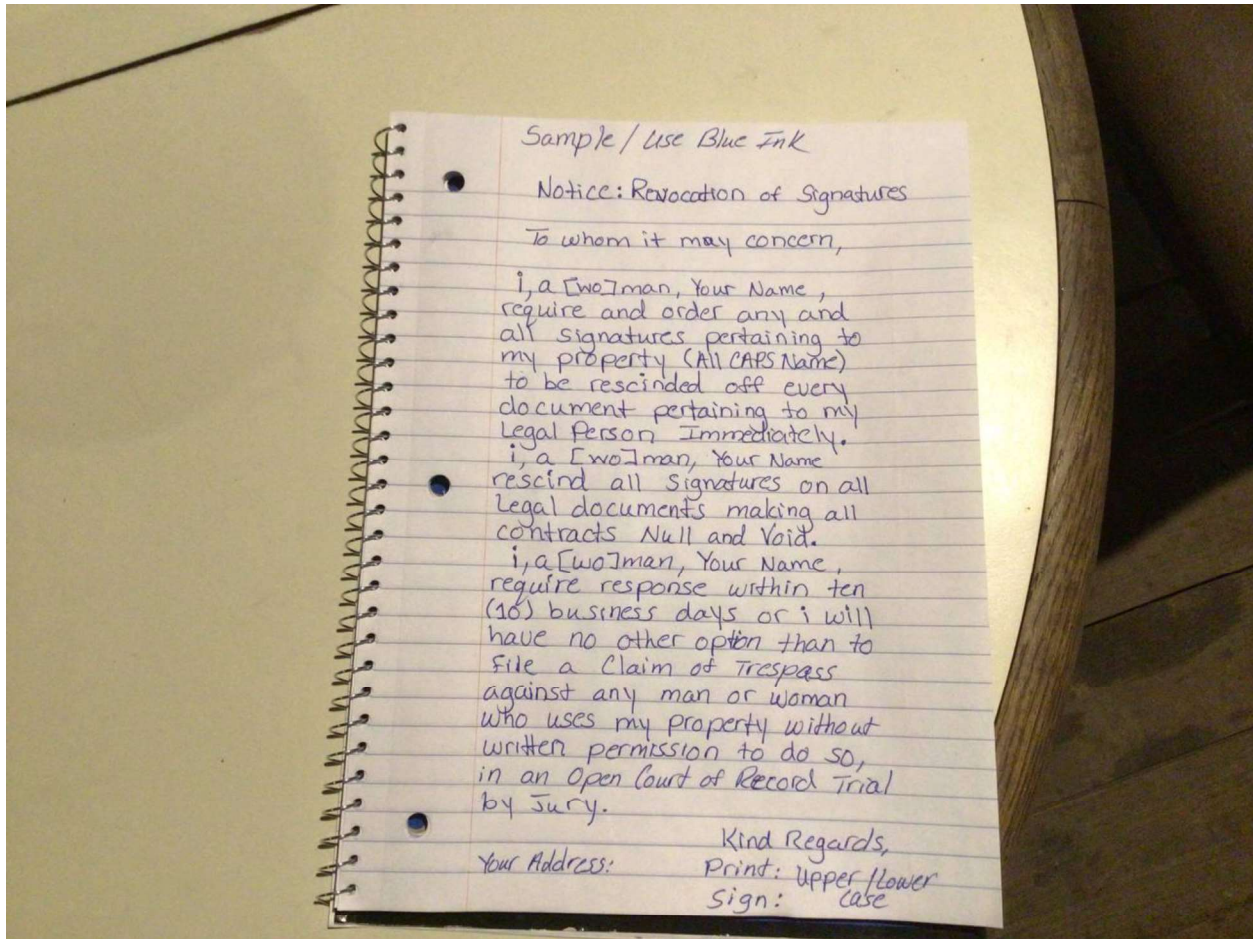

STATEMENT / INVOICES / TRUE BILL

Can a statement be used as an invoice?

No, a statement only provides an overview of what customers have purchased. Invoices are what need to get paid, and after they are, the customer will typically receive a receipt of payment.

STRAWMAN ACCOUNT

The belief in the strawman articulates with [redemption](#)-style schemes, which imply that money from the secret account can be used to pay one's taxes, debts and other liabilities by simply writing phrases like "Accepted for Value" or "Taken for Value" on the bills or collection letters, or that the strawman's funds are accessible through the use of certain [forms](#) and [securities](#). Such schemes are

commonly known as A4V.^[1] By attempting to test this aspect of the theory, one may commit various forms of [fraud](#) and face criminal charges.^{[3][27]} One purported "redemption" method for appropriating the money from the alleged secret account is to file a [UCC-1 financing statement](#) against one's strawman after having taken the steps to "separate" from it.^[3]
